# Data Protection related jobs double year-on-year despite COVID-19

Demand fueled by stricter local and regional data protection requirements and increasing cyber attacks

6 January, 2021, Singapore - The Data Protection Excellence (DPEX) Centre, the learning and research arm of Straits Interactive, today released its annual survey of data protection-related jobs available in Singapore, which increased by 106% year-on-year despite COVID-19.

The survey, now in its fifth year, analysed job vacancies in the month of August 2020 relating specifically to data protection functions or the role of a Data Protection Officer (DPO). There were a total of 245 job posts advertised in August alone, doubling the number of 119 advertised job positions when compared to the same period in 2019.

### **Top Industry Sectors**

Despite COVID-19, there was still active demand for data protection professionals. The top industry sectors include :

- 1. Health, Pharmaceuticals and Biotech (18%)
- 2. Business services (18%)
- 3. Banking & Financial Services (17%)
- 4. Government (17%)
- 5. Computer/Electronics and Software (13%)

The government and the health sector contributed close to 35% of jobs in 2020, due to the Singhealth and related breaches in the health sector during 2019. In addition, recommendations by the Public Sector Data Security Review Committee for government entities that handle public sector data to adopt enhanced data privacy practices created strong demand from the government sector.

#### **Demand for DPOs in ASEAN to increase**

Said Kevin Shepherdson, Head of DPEX Centre "The demand for data protection expertise in Singapore has been steadily growing over the years since the Personal Data Protection Commission (PDPC) started enforcing the PDPA in 2016. This year's 106% rise has been the largest, and can be explained by continued active enforcements, increased cyber attacks and stricter local data protection requirements in both private and public sectors. We expect demand especially for DPOs to continue to grow in the region as Thailand, Indonesia, India and China roll out their data protection laws this year - all of which have a mandatory requirement for a DPO."





The DPEX Centre had estimated back in 2017 that Singapore would require 10,000 data protection professionals over three years. Although COVID-19 has impacted jobs as a whole in Singapore in 2020, the Centre expects demand for data privacy and protection skills to continue to be strong and possibly double over the next three years in ASEAN as Malaysia, the Philippines, Singapore and Thailand will have a data protection law in place.
