We are delighted to work together with Straits Interactive and the Data Protection Excellence Network to bring new operational competencies in data protection to Malaysians. In addition, our graduates and post-graduate students will be able to contribute to the continuing research of data privacy, an area that is currently a green field for ASEAN."

With new data protection laws coming on stream in the region and with tough laws already implemented in the EU and in other parts of the world, it becomes obvious that companies need to be protected against data and privacy breaches, which are not only costly, but in some countries like Malaysia, a criminal act.
