Data Protection Excellence Centre Releases its Data Protection Trends Report for ASEAN and Singapore in 2021

Five key regional trends and challenges amid the COVID-19 pandemic

21 January, 2021, Singapore - The Data Protection Excellence (DPEX) Centre, the learning and research arm of Straits Interactive, today released its 2021 Data Protection Trends Report for ASEAN taking into account the impact of COVID-19 and digitalisation.

"We are pleased to release our view of what data protection trends to expect this year, especially in the Association of South-East Asian Nations (ASEAN). 2021 is the year where all the founding members of ASEAN - Singapore, Malaysia, the Philippines, Thailand and Indonesia - are scheduled to have rolled out data protection / privacy laws and new amendments."The five trends we have identified also take into consideration the impact of COVID-19 and the resulting accelerated digitalisation efforts." said Kevin Shepherdson, CEO of Straits Interactive and Head of the DPEX Centre.

Five Key Regional Trends

- 1. Organisations to shift from predominantly a legal approach to data protection requirements towards a holistic GRC (Governance, Risk Management and Compliance) perspective in their operations relating to personal data.
- 2. A renewed focus on the importance of third party management of personal data due to automation, digitalisation and WFH initiatives resulting from COVID-19.
- 3. While in 2021 will see continued sophisticated cyber threats and data breaches, expect more cases of data breaches involving Intrusive mobile apps as a result of COVID19 and ongoing automation.
- 4. 2021 will also see the European Union's GDPR and ISO 27701 firmly established as de facto standards used for operational compliance and data protection / privacy management.





5. Finally, as public awareness of data protection / privacy grows, the importance of certification both at the corporate and individual level will continue to gain momentum driven by the local data protection / privacy authorities.
